DIRECTOR'S INTRODUCTION



CMI generates and communicates knowledge relevant for fighting poverty, advancing human rights, and promoting sustainable social development.

We seek to understand how poor, vulnerable and marginalized people lead their lives, how their opportunities can be enhanced, how their rights can be advanced, and how institutions can be created that prevent people from falling into extreme poverty.

CMI pursues long term research agendas at the same time as we reorient our research. according to development trends. The upheavals in the Arab world reshaped our agenda in 2011. We follow the region closely through our program on Transformations in the Arab World, focusing in particular on how new power structures reshape the opportunities and constraints for women and religious minorities. We pay increasing attention to the role of new world powers (China, India and Brazil in particular) in development processes. and to issues of food security in the wake of rising food prices and increased vulnerability due to climate change.

Our research output was substantial in 2011. In addition to a number of articles and book chapters, we published quite a few books on issues such as the international project in Afghanistan, the politics of ethnicity in Ethiopia, poverty in Namibia, justice and human rights in Latin America, the role of courts in advancing health rights, and the economics of corruption. We also conducted several important evaluations, including the evaluation of the Norwegian peace efforts in Sri Lanka (1997-2009).

Communication and dialogue with knowledge users are fundamental to bridge the gap between knowledge and action. Our target audience spans from governments and development agencies, to local communities and civil society organizations. CMI researchers also take part in the public discourse. In 2011, our media visibility continued to increase both in Norwegian and international media, especially in countries where we do research.

The U4 Anti-Corruption Resource Centre received favorable evaluations in 2011, and an ambitious new strategy was drafted which reinforced the focus on developing a solid knowledge hub with targeted communication services.


CMI thrives in close partnerships with other research institutions, both globally and locally. An important milestone in 2011 was the new four-year cooperation agreement with the Catholic University in Luanda, Angola, built around a comprehensive research program on Angolan society. Locally, our relationship with the University of Bergen and the Norwegian School of Economics continues to grow, both through project cooperation and through our common communication venue the Bergen Resource Centre for International Development.

In 2011, we have welcomed a number of new staff to CMI, most of them recruited internationally. The competence and diversity they have brought to CMI, is a great strength. Our ability to attract international researchers has confirmed what we have known all along, that CMI is a great place to work. I would like to express my sincere thanks to all staff and to all our partners for your efforts and commitment to research for development and justice.





BLOGGING FROM TAHRIR

Bread, dignity and justice

We did not see them growing up. We did not think these jaded middle-class boys and girls would one day be resilient and hold their ground. Enraged yet nonviolent, they used technology and the vocabulary of democracy to connect and mobilize ordinary Arab citizens of all walks of life and capture the attention of the world. In Egypt, Tahrir Square became the epicenter of the people's demands for bread, dignity, and social justice. Without leaders or a tímetable, but with unconditional demands for immediate change, online activists provided us with physical and social grounds to imagine a new country. We all brought something to the square: blood, medicines, bandages, food, water, blankets, generators, diapers, mobile-phone chargers, garbage bags, wipes, and our own personal notes to the regime (and the world) written in bold letters. Mine just said: "Leave."





Yet there are enormous challenges in implementing health systems that deliver quality services, and in overcoming the economic and social factors that produce ill-health and represent barriers to care.



RESEARCH CONFERENCE IN DAR ES SALAM:

Strengthening human resources for health: Health worker Motivation, Availability and

Performance (MAP) was completed in December 2011. In October, a two day workshop was held at the premises of our partner institution National Institute for Medical Research (NIMR) in Dar es Salaam. Project members and invited speakers presented their findings for an engaged audience of researchers, NGO staff and government officials, including a representative from the Ministry of Health and also from parliament. Earlier in the year, the project's findings were presented in seven of the districts where the data has been collected, and for development partners in Tanzania.

In Guatemala, the practice of indigenous law is a reflection of cultural difference, a response to past and present violence, and a resource for a population denied access to justice. In the postwar period, indigenous law has become a central element of contemporary Mayan identity politics, argues Rachel Sieder.

PAYING TAX BUILDS COUNTRIES

Most poor states are unable to raise the revenue they need for providing basic services to the majority of their citizens. Our research focuses on how governments in poor countries can raise and manage domestic financial resources in ways that enhance their effectiveness and political legitimacy.



OILED PROGRESS OR FOILED PROSPECTS?

Natural resources have an ambiguous impact on development. Income from natural resources increases the wealth of nations directly. Our research focuses on natural resource ambiguities by analysing political and social mechanisms linking or delinking resources and development.
